

MEMBER SURVEY - CONTEST TERMS AND CONDITIONS

This Contest is open to **Bayview Credit Union** Survey participants, who complete the Bayview Credit Union satisfaction survey and meet the criteria outlined below. Credit Union Employees, Directors, and immediate family, as well as employees, of the affiliate companies are not eligible. Participants must be 19 years of age or older to claim the prize. Odds of winning depend on the number of eligible entries received.

The winner will be drawn by **July 13, 2021** and will be contacted within the same week. The winner's name will be published once the winner has been verified and prize claimed.

Official Contest Rules

1. **NO PURCHASE NECESSARY.** A purchase will not increase your chances of winning.
2. **ELIGIBILITY:** To be eligible for this Contest, an individual must: (i) be a member of *Bayview Credit Union* or have completed the satisfaction survey; (ii) be a legal resident of New Brunswick, Canada; (iii) have reached the age of majority in their province at the time of entry; and (iv) complete all applicable questions on the survey. Credit union employees, Directors, immediate family members of employees and Directors, and employees of affiliate companies are not eligible.
3. **HOW TO ENTER:** The Contest begins June 22, 2021 and closes at 11:59pm on July 12, 2021. To enter the Contest, complete the online survey and include your contact details where indicated. The submission of the online entry form indicating contest entry constitutes an 'Entry'. There is a limit of one entry per person. Additional Entries by the same person will be disqualified. All Entries must be submitted no later than 11:59pm on June 12, 2021. All Entries become the property of Bayview Credit Union. Entries will only be accepted via completion of the online survey. Incomplete or late Entries will be disqualified. Unless indicated, no Entries will be accepted by any other means.
4. **WINNER SELECTION:**
 - a. Both winners will be drawn randomly from all eligible Entries received.
 - b. The draw will take place by **July 13, 2021**.
 - c. Chances of winning depend upon the number of eligible Entries received.
 - d. The selected entrants will be notified by phone or email on the date of the draw and must respond within five (5) business days. If the selected Entrants do not respond in accordance with the Contest Rules or the selected Entrants do not comply with the Contest Rules, he/she will be disqualified and will not receive a prize and another Entrant will be selected from the remaining eligible entries. A Contest organizer will attempt to contact the entrant of any such subsequent draw within five (5) business days of such selection and such selection will be otherwise subject to the same conditions as set out in this paragraph.
